The Clay County Board of Supervisors convened as Trustees of Drainage Districts # 10, # 16, #24, #25, #33, #36, #39, #41, #43, #46, #49, #53, #69, #74, #85, #86, #94, #106, #109, #115, #8Branch 4 Lateral 6, #28 Lateral 186-28-008, #48, #114 & #120 Lateral B at 10:52 a.m.

Motion by Swanson, seconded by Skow to appoint Supervisors Anderson as Chair and Clay County Auditor, Marjorie Pitts as Secretary for this meeting. Motion carried.

It was moved by Supervisor Brockshus, seconded by Supervisors Matthews to adopt the following drainage resolution.

BE IT THEREFORE RESOLVED, by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroad in Clay County, Iowa for the Revolving Loan fund the following:

- 10% DD #10 to raise \$1,571.40
- 10% DD #16 to raise \$4,065.60
- 10% DD#24 to raise \$680.30
- 5% DD#25 to raise \$574.25
- 5% DD#33 to raise \$444.75
- 10% DD#36 to raise \$799.70
- 15% DD#39 to raise \$502.35
- 10% DD#41 to raise \$1,924.80
- 25% DD#43 to raise \$237.50
- 3% DD#46 to raise \$1,973.19
- 10% DD#49 to raise \$335.40
- 5% DD#53 to raise \$668.00
- 5% DD#69 to raise \$1,046.30
- 10% DD#74 to raise \$1,558.10
- 5% DD#85 to raise \$737.55
- 15% DD#86 to raise \$105.00
- 15% DD#94 to raise \$122.55
- 20% DD#106 to raise \$277.60
- 5% DD#109 to raise \$493.80
- 5% DD#115 to raise \$1,137.00

BE IT ALSO RESOLVED by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroads in Clay County, Iowa for District Work Assessment the following:

- 10% DD #8 Br. 4 Lat 6 to raise \$1,000.00
- 15% DD #28 Lat 186-28-008 to raise \$642.90
- 15% DD #48 to raise \$2,424.15
- 50% DD#114 to raise \$8,500.00
- 50% DD#120 Lat B to raise \$250.00

BE IT FURTHER RESOLVED, that said assessments be so levied per the current classification schedule with a date of Levy set as May 1, 2016 due and payable upon notice through July 1, 2016 without interest. IF paid after July 1, 2016 an interest rate of 5% will accrue from the date of the levy to September 30 on any single assessment. Any assessment exceeding \$500 per parcel may be paid in installments over a twenty (20) year period by signing a waiver prior to June 1, 2016 at the office of the County Auditor, 300 W. 4th St., Spencer. Any assessment made on any tract of land, parcel, or lot within the District which is computed at less than \$5.00 shall be fixed at \$5.00 as provided by Iowa Code Sec. 468.50.

The above and foregoing resolution was adopted by the Board of Supervisors of Clay County, Iowa, this 26th day of April 2016 and the vote thereon being as follows: Ayes: Anderson, Brockshus, Matthews, Skow and Swanson. Nays: None. Abstentions: None.
