

**Drainage Districts #2 Sub 1; #7; #23; #28; #40; #112; #120 Lateral B;
Jt #14-42 Main; Jt #14-42 Lateral 178; Jt #14-42 Lat 223; Jt #22 Main Meetings**

Held on May 27, 2014

The Clay County Board of Supervisors recessed the regular Board meeting at 9:00 a.m.

The Clay County Board of Supervisors convened as Trustees of Drainage Districts #2 Sub 1; #7; #23; #28 Main; #40; #112; #120 Lateral B; Jt #14-42 Main; Jt #14-42 Lateral 178; Jt #14-42 Lateral 223; and Jt #22 at 9:00 a.m.

Motion by Chalstrom, second by Swanson to appoint Supervisor Matthews as Chairperson and Clay County Auditor Marjorie Pitts as Secretary for this meeting. Motion carried.

Motion by Brockshus, second by Chalstrom that the following resolution be adopted.

WHEREAS, there are now insufficient funds to cover costs of maintenance and repairs to said drainage districts.

BE IT THEREFORE RESOLVED, by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroads in Clay County, Iowa the following:

- 10% DD #2 Sub 1 to raise \$ 1,878.00
- 75% DD #7 to raise \$ 3,578.00
- 40% DD #23 to raise \$ 5,095.00
- 5% DD #28 Main to raise \$ 6,565.00
- 10% DD #40 to raise \$ 1,666.00
- 25% DD #112 to raise \$ 7,650.00
- 100% DD #120 Lat. B to raise \$ 500.00
- 12% Jt DD #14-42 Main to raise \$30,947.00
- 10% Jt DD #14-42-Lat. 178 to raise \$ 1,539.00
- 10% Jt DD #14-42 Lat. 223 to raise \$ 1,762.00
- 50% Jt DD #22 Main to raise \$12,273.00

BE IT ALSO RESOLVED, by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroads in Buena Vista County, Iowa the following:

Jt DD #14-42 Main to raise \$ 5,818.00

BE IT ALSO RESOLVED, by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroads in Buena Vista County and Palo Alto County, Iowa the following:

Jt DD #22 Main	to raise \$ 1,254.00	Palo Alto County
Jt DD #22 Main	to raise \$ 143.00	Buena Vista County

BE IT FURTHER RESOLVED, that said assessments be so levied and payable upon notice through July 1, 2014 without interest. If paid after July 1st, an interest rate of 5% will accrue from date of levy to September 30, 2014 on any single assessment.
