Members present: Supervisors Chalstrom, Matthews, Swanson, Skow and Brockshus.

Motion by Matthews, seconded by Swanson to appoint Supervisor Brockshus as Chairperson for this meeting. Motion carried.

Motion by Skow, seconded by Chalstrom to appoint Marjorie Pitts, Clay County Auditor as Secretary for this meeting. Motion carried.

Motion by Skow, seconded by Chalstrom that the following resolution be adopted.

BE IT RESOLVED, by the Clay County Board of Supervisors that there is hereby levy against all land tracts, real estate, highway or railroads in Clay County, Iowa according to the following percentage schedule by Drainage District:

BE IT FURTHER RESOLVED, that said assessments be so levied as of July 1, 2012 and payable with the current property taxes due September 30, 2012 without interest. Any single assessment on any parcel exceeding \$200.00 shall qualify for a waiver installment option of three (3) payments. The first installment shall bear interest on the whole unpaid assessment from the date of levy to the 1<sup>st</sup> of December following the due date at a rate of 5%. The succeeding annual installments, with interest on the whole unpaid amount, to the first day of December following the due date are respectively due on July 1<sup>st</sup> annually, and must be paid in the same time and manner as the first semi-annual payment of real estate taxes.

BE IT FURTHER RESOLVED, that said assessments be so levied as of July 1, 2012 and payable upon notice through September 30, 2012 without interest. If paid after September 30, 2012, a real estate penalty rate of 1.5% per month will be charged until paid on any single assessment.
