- Above is a sample report of the Tax Levy Rates for Clay County, Iowa. The individual columns show Tax Levy Rates for the specific Levy Authorities in that row. For example, each of the sixteen townships has its own specific Tax Levy Rate. The Total column above is the **Consolidated Tax Levy Rate** for the respective Tax District. The cities above have different Tax Levy Rates for their respective regular Tax Districts. However, each can levy up to 3.00375, which is the maximum allowed by law for their agricultural Tax Districts. Township Tax Levy Rates can include levies for fire protection, cemeteries, township halls, etc.
- The Clay County countywide Tax Levy Rate is \$6.42130 per thousand, and taxpayers in incorporated cities pay that rate only. The County rural services Tax Levy Rate of \$3.87293 is added to the countywide rate, and taxpayers in unincorporated townships pay the total of \$10.29423 per thousand.
- "Other" includes Tax Levy Rates for Levy Authorities, including the community college, county agricultural extension council, local assessor, and the State of Iowa.
