Motion by Anderson, seconded by Matthews to approve the payment of drainage claims for postage to Neofunds from various ditches located in Clay County and the Drainage Revolving Fund #51999 totaling \$435.52. Details on file at the county auditor's office. Motion carried.

Motion by Skelton, seconded by Hamrick to approve postage payback payment of \$34.25 to the Drainage Revolving Fund #51999 for drainage postage claims previously paid by the Drainage Revolving Fund. Details on file at the county auditor's office. Motion carried.

The Board discussed the method to replenish the Drainage Revolving Fund at their April 28, 2015 meeting. Drainage Districts that had funds available at that time paid \$.30 per acre to the Drainage Revolving fund. Several of the other drainage districts now have funds available to pay their \$.30 per acre levy to the Drainage Revolving fund. Motion by Anderson, seconded by Hamrick to direct the Clay County Auditor to issue warrants for the specified amounts from these individual drainage districts payable the Drainage Revolving fund. The change is due to longevity increase for five years of continued service. Motion carried.

Motion by Anderson, seconded by Hamrick to acknowledge the removal of Bankers Trust Company, 453 7th St, Des Moines, IA as the Trustee, Escrow Agent and/or Paying Agent for the General Obligation County Refunding Bonds, Series 2016A associated with the Clay County Law Enforcement and Jail and assign the Trustee, Escrow Agent responsibilities to UMB Bank of Kansas City, MO. The effective date of closing is anticipated to occur on or about June 10, 2019. Motion carried.

#### **RESOLUTION NO. #2019-13**

## A RESOLUTION OPPOSING SENATE STUDY BILL 1045 AND SENATE FILE 184 PASSED BY THE SENATE COMMITTEE ON TRANSPORTATION

WHEREAS, the Transportation Committee in the Iowa Senate has passed House Study Bill 1045 (SF 184) which would amend and make changes to Iowa Code Chapter 321 related to transportation of indivisible loads and raw forestry products on primary and non-primary highways, and:

WHEREAS, Clay County owns and maintains nonprimary highways, and is fiscally and legally responsible for the nonprimary highways within the County, and;

WHEREAS, many of the bridges owned by Clay County are aging and structurally deficient or functionally obsolete, and;

WHEREAS, Clay County owns and maintains 137 structures classified as bridges by the National Bridge Inspection Standards, and;

WHEREAS, many of the bridges owned by Clay County are aging and structurally deficient or functionally obsolete, and;

Clay County Board of Supervisors March 26, 2019 WHEREAS, current funding is not adequate to replace or rehabilitate these bridges at the rate their conditions are deteriorating, and;

WHEREAS, the nonprimary roads and bridges owned by Clay County serve a critical need for residents, agricultural users, businesses, schools, l post offices, and emergency responders, and;

WHEREAS, the proposed bill would allow the Iowa Department of Transportation to issue annual permits to forestry industry haulers for loads up to 130,000 pounds on nonprimary highways throughout Iowa, without knowledge of or notice given to the agencies which own these highways and the structures thereon, and;

WHEREAS, bridges within Clay County have been designed for loads that were legal on Iowa roads at the time of their construction, and bridges have only been rated or posted with weight restrictions for loads that are currently legal on roads, and;

WHEREAS, each bridge within Clay County is unique based on its age, design, and current condition, and:

WHEREAS, load rating to ensure safe passage of loads greater than 80,000 pounds would be unique for each load on each individual bridge, and;

WHEREAS, the traversing of Clay County bridges by loads up to 130,000 pounds without the County being afforded the knowledge of or the ability to restrict each occurrence, would result in gradual and possibly sudden failure of bridges within the County, and;

WHEREAS, Clay County would likely bear legal and financial liability for subsequent failure of its bridges, even if such failures are caused by loads they did not permit, and;

WHEREAS, Clay County is not financially able to repair, or replace bridges which would be subject to accelerated deterioration by increased loads, and;

WHEREAS, Clay County and its residents, farmers, businesses, schools, post offices, and emergency responders, would be subjected to undue operational and economic hardships by further degradation of its road system and the structures thereon;

THEREFORE BE IT RESOLVED, that the Clay County Board of Supervisors strongly urges all Iowa lawmakers to vote in opposition to this legislation.

### 9:45 a.m. M50 Culvert Bid Letting

Motion by Anderson, seconded by Hamrick to accept the low bid of \$266,806.00 from Midwest Contracting LLC out of Marshall, Minnesota for Culvert Replacement on 240<sup>th</sup> Avenue – ½ mile N. of Co. Road B-24, Project Number LFM-2019C-1—7X-21, and Authorize the Chairperson to sign the contract. Motion carried.

**10:00 a.m.** Spencer Community Theatre (SCT) Board Chair Kristi Busse and Interim Executive Artistic Director Liz McNea spoke with the Board regarding their request for local funding in fiscal year 2020. The Spencer Community Theatre is a non-profit organization that does not regularly receive local tax dollars for its continued operation. SCT has customarily received yearly grant money from the Iowa Department of Cultural Affairs for special projects and general operations. However, their application was declined for the 2019 three-year cycle. For this reason, there is an increased need and value to a local allocation. The Board confirmed that a \$1,500 allocation has been appropriated for the 2020 fiscal year.

**10:15** *a.m.* The Board met with Mrs. Connie Swan, a rural land owner in Drainage District #37. Mrs. Swan was accompanied by Robert Swan, Dale Langner, and Alan and Cindy McGranahan. Mrs. Swan gave the Board a copy of Iowa Code Section 468: Subchapter 1: Part 1, Section 10 regarding appointing a disinterested and competent civil engineer. Mr. Robert Swan also spoke to the Board. The Board, under advice of Counsel, did not discuss any of the comments brought forward due to pending litigation filed by Robert Swan, Alan McGranahan, and David Wyatt vs. the Clay County Board of Supervisors, and the Clay County Drainage District #37.

### 10:30 a.m. County Government Month Proclamation for April 2019

Motion by Anderson, seconded by Matthews to authorize the Chairperson to sign the 2019 County Government Month Proclamation to be celebrated in April 2019. Each year since 1991, the National Association of Counties has encouraged counties across the country to actively promote programs and services to the public we serve that provide essential services to create healthy, safe, vibrant and economically resilient communities. Motion carried.

**10:45** a.m. County Sheriff Chris Raveling and Chief Deputy Zach Larsen discussed new personnel changes for their department. Raveling has plans to establish and promote two deputies to the rank of sergeant this fiscal year. The promotions are feasible within both the current budget and the budget for fiscal year 2020. They would be in charge of their own team of three deputies. There was no Board action taken and Supervisor Matthews suggested that no Board action would be necessary.

11:00 a.m. The Board met with Denise Ballard and Cindy Allen representing the Iowa Governmental Health Care Plan (IGHCP) that provides health benefits to the employees of Clay County and Todd Ackerman from Employee Benefit Systems (EBS) that administers the County's partial self-funding component. The annual renewal for fiscal year 2020 was discussed. The fully insured partially self-funded health plans have had a change in total premium rates averaging 3.1% percent annually since entering the IGHCP Trust in 2005.

Motion by Matthews, seconded by Hamrick to approve and authorize the Chairperson to sign recommendations for IGHCP Health Renewal for the fiscal year 2020 health and dental insurance

rates for the County. The projected fiscal year 2020 county cost of health care will be \$96,003 over FY2019 or a total of \$1,467,818 for FY2020. Motion carried.

**11:30** *a.m.* The Board met with Brooke Sievers, PE and Bryan Paulsen, representing ISG Architects of Storm Lake, IA. The Board wishes to have a thorough site and facilities assessment of the County Administration Building, the County Courthouse, and the Government Services Center. ISG proposed the assessment would focus on areas such as building conditions, interior conditions, mechanical systems and controls, electrical and lighting systems, energy savings opportunities relative to windows, doors, etc., building code and accessibility considerations and the flexibility for integrating new technologies. The Board will act on the proposal at their next regular meeting Tuesday, April 9, 2019.

Supervisor Anderson leaves the meeting at 12:30 p.m.

Supervisors discuss/share information from committees and boards they have attended. Supervisor Swanson reported on the Clay County Visitor Bureau Board meeting and the Emergency Medical Services meeting. Supervisor Skelton reported on the Law Emergency Planning Committee (LEPC) and the Iowa State Association of Counties (ISAC) Conference. Supervisor Matthews reported on the ISAC Conference, the Season's Center Board meeting, and the RIDES Board meeting. Supervisor Hamrick reported on the Northwest IA Planning and Development Council Board meeting.

The Chairperson adjourned the meeting at 12:55 pm to convene at the next Auditor's called meeting March 29, 2019 at 215 p.m.
