The Clay County Board of Supervisors convened as Trustees of Drainage Districts #5 Outlet; #8 Branch 4 Lateral 2; #32 Main; Jt #14-42 Lateral 198; Jt #22 Branch 158 Tile; Jt #22 Lateral 252; Jt #52 Meetings at 9:39 a.m.

Motion by Matthews, seconded by Brockshus to appoint Supervisor Swanson as Chair and Clay County Auditor Marjorie Pitts as Secretary for this meeting. Motion carried.

It was moved by Brockshus, seconded by Matthews to adopt the following drainage resolution:

WHEREAS, there are now insufficient funds to cover costs of maintenance and repairs to said drainage districts.

BE IT THEREFORE RESOLVED, by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroads in Clay County, Iowa the following:

- 25% DD #5 to raise \$4,719
- 10% DD #8 Br 4 Lat 2 to raise \$1,001
- 5% DD #32 Main to raise \$3,262
- 5% Jt DD #14-42 Lat 198 to raise \$1,361
- 200% Jt DD #22 Br 158 Tile to raise \$3,495
- 10% Jt DD #22 Lat 252 Tile to raise \$2,188
- 20% Jt DD #52 to raise \$2,073

BE IT ALSO RESOLVED, by the Clay County Board of Supervisors that there is hereby levied against all land tracts, real estate, highway or railroads in Palo Alto County, Iowa the following:

- Jt DD #52 to raise \$1,400.80

BE IT FURTHER RESOLVED, that said assessments be so levied and payable upon notice through July 1, 2015 without interest. If paid after July 1, 2015, an interest rate of 5% will accrue from date of levy to September 30, 2015 on any single assessment.

The above and foregoing resolution was adopted by the Board of Supervisors of Clay County, Iowa, this 28<sup>th</sup> day of April, 2015 and the vote thereon being as follows:
